Step 1: Intent to Renew

Agencies receiving FY22 CoC Program Awards must complete and submit an Intent to Renew form!

- Form will be posted at: <https://www.ncceh.org/bos/currentcocapplication/>
- An Intent to Renew Form is needed for each renewal project.
- Intent to Renew Form is due by **Tuesday, April 25th by 6 PM.**

Information to Submit:

- HUD CoC Grant Number
- Name of Renewal Project
- Project Type: RRH or PSH
- Intent to Renew
 - Yes, for the full award amount
 - Do you also intend to apply for an Expansion of this project?
 - If yes, complete an Intent to Apply form
 - Yes, for less than the full award amount
 - No, we do not intend to renew



Step 2: Pre-Competition Scoring & Standards Review

The NC BoS CoC has designed a Pre-Competition Scoring and Standards Review for Renewal Projects.

- To make the HUD CoC Competition less hectic for renewal grantees, the Project Review Committee, and the CoC.
- To assist agencies to enhance their project's performance outside the time-restricted competition.
- To better serve people experiencing homelessness across our 79 counties.



Step 2: Pre-Competition Scoring & Standards Review

Pre-Competition Scoring & Standards Review items will be recommended by the Scorecard Review Committee in the 2023 Renewal Applicant Scorecard approved by the Steering Committee on April 4th.

In general, we will likely review the sections on Housing First, Key Elements of PSH, RRH Benchmarks and Program Standards, PSH Moving-On Strategy, Targeting to Prioritized Subpopulations. We're also likely to review the Populations Served portion of the Project Performance section and the section on Coordinated Entry and Prioritization.

Renewal projects will submit by **April 27th by 6 PM** via Smartsheet.

- Renewal Applicant P&Ps Page Number Detail Form



Step 3: Certification

Between April 28th and May 19th, CoC staff will:

- Review all documents submitted for the Pre-Competition Scoring & Standards Review
- Pull and Review additional HMIS reports (CH Report, SPM Returns Report)



Projects meeting ALL HOUSING FIRST and PROGRAM DESIGN STANDARDS will be *Certified* for a 3-year term (2023-2025).

FY2023 Certified projects will not have to re-submit documentation for these Standards again until the FY2026 competition!



Step 3: Certification

Projects *not achieving* Certification in FY2023:

Between May 25th and June 2nd, CoC staff will:

- Hold Agency Review Meetings with grantees not achieving Certification due to unmet Standards and offer Technical Assistance.
- These grantees will have the opportunity to meet the Standards to be Certified for FY2024 by submitting revised documents by Thursday, June 8th by 6 PM.
- CoC staff will review the revised documents and complete the Certification process for all renewal project grantees by Friday, June 16th.

Projects achieving Certification for FY2024, after resubmitting documents, will be Certified for a 3-year term (2024 – 2026)

FY2024 Certified projects will not have to re-submit documentation again until the FY2027 competition!

Step 4: HUD CoC Competition

Step 4 will be launched after the release of the FY2023 HUD Continuum of Care Notice of Funding Opportunity (NOFO).

Instructions will be released soon after HUD publishes the NOFO. CoC Program competition materials and instructions will be posted at: <http://www.ncceh.org/bos/currentcocapplication/>.

The CoC Program NOFO officially opens the competition and defines the rules. The NOFO sets:

- Timelines
- Priorities/Scoring
- Final Funding Allocation/Tiering
- Potential projects
- CoC and project applicant requirements

Application materials will be reviewed by the Project Review Committee using the FY2023 Renewal Applicant Scorecard. Scores from the Pre-Competition Scoring & Standards Review will be added.



Step 5: Submission of Final Application in e-snaps

The due date of Step 5 will be determined by the HUD CoC Notice of Funding Opportunity (NOFO).

The Project Review Committee will score and rank all renewal and new applications into Tiers 1 and 2.

The Project Review Committee will recommend a final Prioritization Ranking List to the Steering Committee for approval.





Next Steps

Next Steps

- Submit an *Intent to Renew* by Tuesday, April 25th by 6 PM.
- Review the FY2022 Renewal Applicant Scorecard.
- Be ready for the FY2023 Renewal Applicant Scorecard, the Pre-Competition Scoring and Standards Review Link to submit documents, and the Renewal Applicant P&Ps Page Detail Form to go live on our website by April 5th.
- Submit your Pre-Competition Scoring and Standard Review documents by Thursday, April 27th by 6 PM.
- Certification determinations by June 16th.
