CoC Application Update

- Public Housing Authorities are now eligible applicants
- If a PHA in your area wanted to complete the pre-application and did not, contact us ASAP.
- Pro Rata is different this year, now includes ALL renewals including Shelter Plus Care
- Balance of State cannot handle pro rata as we have before. The pro rata figures from HUD are no longer applicable.

Application Sub-committees

- Two subcommittees are needed for the BoS CoC NOFA application.
 - Review Criteria (Scorecard) Subcommittee
 - Project Review and Ranking Subcommittee
- Renewal Scorecard
- **Regional Lead Action Items:**
 - Determine who will represent your RC on these subcommittees. The same person can serve on both committees, or you can choose different people. Project Review Subcommittee members may NOT be applicants for new projects in the 2012 application.
 - Send who will represent your RC on these subcommittees to bos@ncceh.org by Nov. 9th.

2013 Point-in-Time Count

- Point-in-Time Count will be night of Wednesday, January 30, 2013
- Collect data on homeless people for PIT Count and bed inventory info for BoS Housing Inventory Count (HIC)
- Changes for 2013 count:
 - Count rapid re-housing programs (ESG-funded, CoC-funded, or other) – considered permanent housing
 - Count people by age category: under 18, age 18 to 24, and over 24
 - Count number of one-child households and number of multi-child households in “households of only children” category
 - Count number of male vs. female veterans
