Regional Committees within NC BoS are responsible for submitting regional applications to NC DHHS and agencies submit program applications to their regional committees based on local timelines. NC DHHS will conduct an informational webinar on Thursday August 8 from 2-4 p.m.</p> <p>The Balance of State CoC has the authority to approve Regional Committee applications to ESG. The Steering Committee will give direction to NCCEH staff on how to handle this year’s approval process.</p>

	<p><b>Background Information:</b> HUD began a 10-week communications strategy called SNAPS Weekly Focus on July 2 which details HUD’s funding priorities for the upcoming CoC Application competition. Corey is distributing these emails to Regional Leads and CoC project grantees. HUD seems to be signaling releasing this year’s application in mid-September.</p> <p>Questions posed from HUD:</p> <ol style="list-style-type: none"> <li>1. Is permanent supportive housing being used in a strategic manner that prioritizes those that need it most (as opposed to first come, first serve)?</li> <li>2. Is permanent supportive housing being implemented using a housing first model?</li> <li>3. Is rapid re-housing being used as effectively as possible?</li> <li>4. Is the CoC taking all necessary steps to implement a coordinated assessment system?</li> <li>5.
